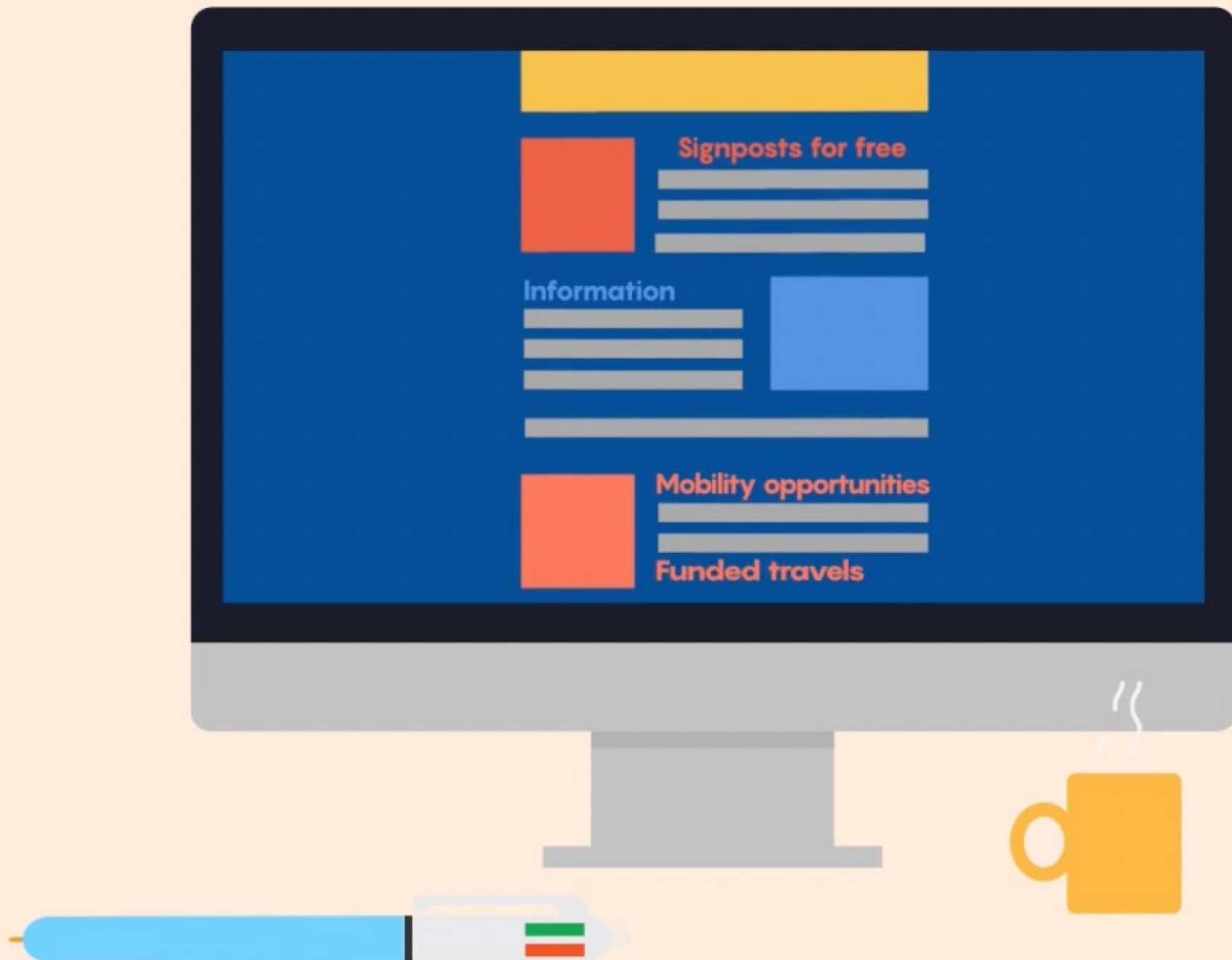

Administrative processes for UK dancers/company going to EU/EEA

Dancers / choreographer (each individual)

- Citizenship
- Validity passports
- Numbers of days spent in Schengen zone visa free
- Getting social security form
- Getting Global Health Card

Administrator

- Check **tax** treaties (if any, exist on bilateral level)

Company

- consider if ATA **carnet** is needed

On venue / festival side

- Formal **letter of invitation**
- Define clearly what the artist/company is doing (residency, performance, lecture, workshop,)
- Confirming no need **work permit** / within exceptions or work permit needed (well in advance)
- Depending on country (France!), making employment **contract** if needed
- Specify clearly on payment if **taxes** and social security charges have been collected or not!

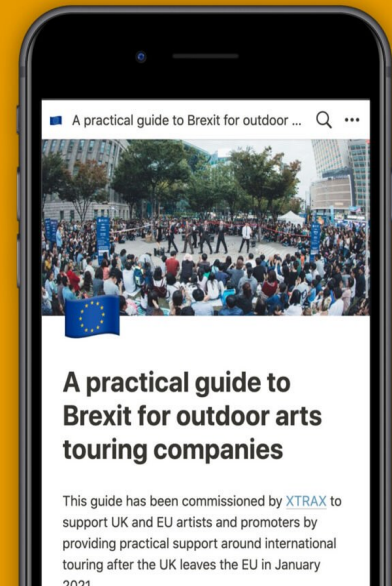

Dance Sector Brexit Working Group

Movement Beyond Borders (2018):

- 86% respondents estimate Brexit will have impact on UK based work & productions
- 96% of respondents estimate that Brexit will have impact on touring
- No alternative to EU funding

What's next?
